





- Requirements:**
- Artist must be eighteen years of age or older
 - Size limits on two-dimensional artwork, fiber art, photographs or construction on any surface are 42 inches by 42 inches
 - Three-dimensional work **CANNOT BE** accepted this year for case display.
 - Series pieces may be submitted, but each section or panel will constitute one entry.
 - No nudes accepted.
 - Framing with brackets is **NOT** acceptable.
 - Only suitable **wire hangers** are acceptable
 - Fragile, wet, or improperly framed or mounted work will not be accepted.
 - All objects must be assembled and ready for hanging.
 - All entries must be originals, no copies.
 - Each piece must have a separate entry form. Additional forms will be available at drop-off.

- Judging:** Entries will be judged Saturday afternoon, April 29, 2017. Artists whose work has not been accepted by the judges will be called between 2:30-3:30 p.m. Please have someone available to accept phone calls. Unaccepted work must be picked up between 3:30-4:30 p.m. on Saturday April 29, 2017.
- Awards:** Winners will be announced and awards presented at a reception on Friday, May 5, 2017 from 7:30-9:00 P.M. at the Municipal Gallery in the Municipal Building. Refreshments will be served.
